### Events:

Men's singles, Women's singles, Men's doubles, Women's doubles and Mixed doubles.

The max amounts of entries which can be accepted in each event are Men's & Women's singles (64), Men's & Women's doubles (32), Mixed doubles (48)

If the number of entries exceeds the amount listed above, a selection of entries will be made in accordance with regulation 6.1.5 of the Badminton Europe Junior Circuit Regulations.

In accordance with regulation § 9.2 and § 9.3 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 8 (eight) competitors in the first published version of the main draw. If the required number of competitors is not met in the first published version of the main draw, this particular event shall not count towards any ranking.

In accordance with regulation § 9.4 in BWF Statutes, Section 5.3.3.2: World Junior Ranking System, an event must contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw. If an event does not contain at least 1 (one) entry from a Member other than the hosting Member in the first published version of the main draw, this particular event shall not count towards any ranking.



Each player is allowed to play in **3 events**.

The tournament will be played according to the knockout-system in accordance with the rules of BWF and **the regulations of the Badminton Europe Junior Circuit**. All matches in all events will be played according to the international rules. Seeding and the draw will be made by Badminton Europe.

**Eligible players:**

All players of clubs affiliated their national Associations to the BWF - and born 2006 or later.

**Umpires:**

There will be umpires in all matches. Service judges and line judges will be present from the semifinals. Please note that Service height measuring device will be present from SF.

**Shuttles:**

**Clothing and Advertising:**

Colour, design, lettering and advertising on clothing shall be regulated by BWF Statutes, Section 5.2.3: Junior Tournament Regulations § 12 to 16. A player violating these regulations shall be penalised by an administrative fine of 50,00 EUR.

It is mandatory for the semi-finals and finals that partners in doubles wear the same colour of the T-shirt and shorts/skirts. Failing to do so shall result in an administrative fine of 50,00 EUR.

**Entry fees:**

Entry fees - **to be paid before the tournament** - are:

Singles: Dkr. 450,- (60,- Euro)      Doubles: Dkr. 600,- (80,- Euro) per pair.

Shuttles are included in the entry fees. The Member that enters a player/pair into a BEC Junior Circuit tournament is responsible for paying the entry fees for that player/pair. The entry fee becomes due if a player/pair is entered and has not been withdrawn when the entry deadline passes. It is recommended that the entry fees are paid by bank transfer, but the organisers can accept cash payments at tournaments. The entry fees will not be refunded in the case of a withdrawal. For all the withdrawn players the organizers can invoice the entry fee to the relevant Member.

*All players incl. the Danish players will have to go through their national Member Association.*

**Compliance with General Competition Regulations Clause 7.9**

GCR 7.9: *“In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF’s regulations and Disciplinary processes.”*

For International teams it will only be possible to pay via International bank transfer. Information will be provided in due time together with the invoices.

**Prizes:** 1st and 2nd prizes will be awarded in all events.  
*3rd prizes will be awarded in events with more than 24 entries.*

**Practice:** Practice courts will be available Wednesday and Thursday mornings up to the tournament but NOT during the tournament. Please contact organizers.

**Transport:** The official point of arrival is Gentofte train Station. This station can be reached from Copenhagen Airport train station (Ticket counters in Terminal 3). Transport from the Airport to Gentofte Train station requires minimum one train shift. Transport between Gentofte Station and the official Hotel (only) will be provided by the organizers on request. Please note that the distance from the station to Gentofte Hotel is 700 m. The organizer will not provide transport to other hotels or between the Official Hotel and the tournament venue. Please also note that after the tournament has started no transport will be provided.

**Doping Control:**

Doping control in badminton, in accordance with BWF Anti-Doping Regulations, is conducted out-of-competition and in-competition with the collection of urine and/or blood samples.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).

**Badminton Integrity:**

Section 2.4 of the BWF Statutes (Code on The Prevention of The Manipulation of Competitions) relates to anti-corruption and anti-match manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, shall respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a match(es).
